

# DRACUT TO OPEN FREE FITNESS COURT® AT VETERANS PARK FOR ALL RESIDENTS

## State-of-the-Art Outdoor Fitness Court® Coming to Veterans Park

(DRACUT – October 25, 2023) [Blue Cross Blue Shield of Massachusetts](#), the Town of Dracut and [National Fitness Campaign](#) today announced a partnership to bring an outdoor Fitness Court to Dracut. The Fitness Court, at Veterans Park, will open Wednesday, November 1 at 12 p.m. with a ribbon-cutting ceremony.

The Fitness Court was developed by Blue Cross, the Town of Dracut and NFC to expand free access to high-quality workouts and create equitable access to exercise for communities across Massachusetts. The Fitness Court lets people use their own body weight to experience a complete workout using seven exercise stations.

The workouts, created for ages 14 and older of all abilities, are adaptable for all fitness levels, allowing participants to move at their own pace. Users can also download the free [Fitness Court App](#), which enhances the outdoor gym into a digitally supported wellness experience.

“Blue Cross is committed to helping people live healthy lives and eliminating the physical and social barriers that lead to health disparities,” said Jeff Bellows, vice president of corporate citizenship and public affairs for Blue Cross Blue Shield of Massachusetts. “We’re proud to partner with NFC and the Town of Dracut to launch a Fitness Court that will provide Dracut residents a communal gathering space and access to premier free outdoor fitness opportunities.”

Dracut is one of 15 Blue Cross Fitness Courts currently open or under construction in easily accessible public spaces. Blue Cross’ sponsorship of NFC is part of the company’s strengthened corporate citizenship commitment to promote health justice in communities across Massachusetts.
